Dehydration! A fantastic meeting on the subject of hydration and dehydration this month organised by the European Hydration Institute and held at the Royal Society of Medicine. The talk that resonated most with *TTUK* was the research carried out on the effects of dehydration on drivers. The effects on health of dehydration are horrendous and one of our own *TTUK* supporters

has described her own experience of landing up in hospital because of dehydration. Dehydration causes lapses in concentration so the consequences can be dire not only for lorry drivers but for other road users. Needless to say there were discussions about the lack of toilets for lorry drivers which encourage drivers to reduce their fluid intake so they don't have to pee. This is a highly dangerous situation which Government is failing to recognise. Do our drivers have to wait for even more research to be carried out before action is taken?

Department of Health: Well, in answer to the question above it seems they do. A letter was sent to Jeremy Hunt, our Secretary of State for Health about the

importance of hand hygiene and the need for facilities for lorry drivers. Mr Hunt had visited the company of one of our supporters and apparently recognised the importance of hand hygiene in hospitals. However, he didn't think it that important when it came to improving facilities for lorry drivers.

His response was to suggest it would be better to contact the Department for Transport! Do you remember the DfT's response dated 19 December last year? Let *TTUK* remind you '.the Government has no powers to intervene....'

Hand hygiene: If you're lucky enough to have access to a washroom with both paper towels and hand driers which should you choose? According to the latest research by the University of Westminster [commissioned by the European Tissue Symposium and based on previous work by University of Leeds] paper towels are best [The Cleanzine 30 April]. However what isn't stated is whether there are any problems apart from unpleasant messiness if the user misses the bins.

Commercial Motor: Taking up the cudgel on our behalf once again, Chris Tindall wrote an excellent article dated 4 June headed '*Truckers*' *Toilets founder says* government doesn't give "two hoots" about drivers' health'. He asked Gill for quotes and got them! The article also mentioned how *TTUK* and Blue Arrow are working to get Government to agree minimum standards for HGV toilet facilities.

Blue Arrow A lively meeting with the Drive with Pride team was held this month. As awareness of the driver shortage increases - partly due to the lack of toilet and washing facilities - we brainstormed some solutions and ways they could be progressed. Watch this space for updates.

Drive with Pride Petition: The petition is gaining momentum. Forecourt Trader [15 May] included a piece on it and mentioned *TTUK*'s partnership with Blue Arrow. The lack of toilet facilities for drivers was suggested as a contributing factor to the driver shortage. Have YOU signed it yet?


be broadcast on every television and radio station; but the 'humble old truckie gets told to just keep on trucking'.

What's in a name? Thank you to one of our TTUK active supporters, Michelle, who recently pointed our Ed in the direction of a DfT document 'The Strategic Road Network and the Delivery of Sustainable Development dated September 2013. Apparently this replaces a document of 2008 'Policy for Service Areas and other

Roadside Facilities on Motorway and All-purpose Trunk Road in England'. The new document includes requirements for service areas and truck stops at regular intervals and states the facilities to be provided including toilets and showers – and the length of time they are to be open

although there is nothing about cleaning!!! So it seems that the DfT does have input into facilities! [Our Ed finds this all rather confusing and as our supporter points out, the title of the document itself is not particularly enlightening as to the content.]

Highways Agency is an executive agency of the Department for Transport and is responsible for operating, maintaining and improving the strategic road network in England on behalf of the Secretary of State for Transport. guided by its core principles of 'safe roads, reliable journeys, informed travellers'. The presentation included employers' legal responsibilities but noone apparently cheered at the suggestion that employers should invest in facilities on sites for which

Menstrual Hygiene Day: This is a global event held on 28 May and was the second occasion on which the subject of menstruation had its own day. The aim is to talk about periods and build awareness of the need for good menstrual hygiene. Again

the words 'dignity' and 'safety' were used, the focus being, it seemed, on those countries where periods are a taboo subject and facilities to cope with them are virtually non existent. Perhaps next year we should highlight the position of women lorry drivers in this country. They have to

cope without proper access to hygienic facilities which lead to some of them taking drastic action to avoid what is after all a natural part of being a woman. This is

another topic which is ignored when it comes to providing proper facilities for female drivers.
